Credit Agreement

Applicant, and if more than one, each of them, understands and agrees to the following credit terms.

- Net 10th. All invoices are due on the 10th of the month immediately following the invoice date.
- Earn a 2% credit by paying your statement balance with a **check** by the 10th of the following month.
 - This is **not** a cash discount and may **not** be deducted from your payment. Rather, it is a **credit** which is applied to your account and which will appear on your next statement.
 - Payment must be postmarked not later than the tenth of the following month, i.e., by June 10th for the May statement.
 - This does not apply to credit card payments or our Online Payment Portal because of the fees we are charged on bankcards.
 - This credit will be computed only on the current charges on the statement. Past-due charges will not qualify for the credit.

- Statements are emailed the first of the month for the previous month's charges.
 - Statement include both Tualatin and Carver charges.
 - Statements can be customized to show all invoices for the statement period or for all open transactions as of statement date.
 - Statements show all details of the POS sales receipt; therefore, copies of invoices, credit memos, and POS sales receipts are not provided.
 - POS sales receipts are provided at the time of transaction. We suggest your drivers save and turn in these receipts for your records.
 - POS sales orders are used for quote or order estimates and are non-posting for bookkeeping purposes. Actual purchases become POS sales receipts.
- Past due invoices are subject to a 1.5% monthly finance charge (18% per annum).
- Non-Current (past due) accounts will be placed on a cash basis at the option of Voss Materials, Inc.
